



### Wedding and Civil Ceremony Terms

- **1.1 CONTRACTED PARTIES:** This is an agreement between 'the client' and Craig Beck, operating under the trading names Craig Beck Wedding Photography and Craig Beck Cyprus.
- **1.2 BOOKING FEE:** A non-refundable deposit of **€100.00** is required. Dates will be reserved only when this deposit is paid by credit/debit card, cash or cheque. Please make euro cheques payable to **Craig Beck**. A full unconditional refund policy exists for a period of 7 days from receipt of the contract and payment. After that date, refunds are at the discretion of Craig Beck Wedding Photography. **Payment of a deposit is an indication of acceptance of these terms; do not pay the deposit if you cannot accept all of these conditions**
- **1.3 CANCELATIONS:** Any cancellations within 8 weeks of the agreed wedding date will incur the full cost of the agreed package.
- **1.4 PAYMENTS:** The balance of payment for the photography must be settled in full before the wedding day by wire transfer, cash or cheque. Any bank charges incurred due to returned cheques will be charged to the client. In the event of either the deposit or balance not clearing in a UK bank any dates reserved will become available to other wedding parties with immediate effect.  
All re-orders shall be considered an extension of this contract. All re-orders must be paid for in full prior to orders being dispatched.
- **1.5 REQUESTED PHOTOGRAPHS:** While no guarantee can be included the photographer will attempt to honour photographs requested and agreed in advance, provided the following factors are met: Weather and allocated time permitting, availability and co-operation of the person/s concerned. For weddings with over 250 guests a second photographer is required.
- **1.6 COVERAGE:** The Photographer cannot be held responsible for the lack of coverage caused by: the bride, the groom or wedding party not being on time, the Church, registry office, or licensed place of wedding having restrictions regarding photography. The Photographer does not undertake to guarantee any specific picture nor incorporate any specific background, location or group arrangement. Additional coverage beyond the agreed times will be invoiced at €150 per hour. The term 'Full day wedding photography' assumes a maximum duration of 6 hours or up to 20.00, whichever comes first.
- **1.7 COVERAGE EXTENSION:** 'Late reception coverage' upgrade assumes a maximum of an additional 2 hours service. First dance coverage is considered photography coverage to not later than 22.00. Sustenance must be provided to the photographer for shoots continuing after the wedding breakfast (a sandwich and soft drink is all that is required).
- **1.8 HOTEL RESTRICTION OF COMPETITION CLAUSES:** A few hotels in Cyprus are now asking for additional fees or insurance fees to be paid by 'external' photographers for the right to shoot on site. This is purely an attempt to force the client to use the photographer the hotel has a contract with. Any additional fees required by the hotel are to be met by the client.
- **2.0 WEATHER, ILLNESS & 'ACTS OF GOD':** Craig Beck cannot be held responsible for images and photography sessions being disrupted by adverse/unfavourable weather conditions. Craig Beck shall not be liable for any amount in excess of the retail value of your package. We may substitute photographers to take photographs at your wedding in the event of photographer's illness. We may not be held responsible for 'acts of God' or unpredictable events (e.g. motor vehicle breakdown, flight cancellations or industrial action etc)
- **3.0 EXCLUSIVITY:** Craig Beck shall be the exclusive photographer retained by the client. Family and friends are permitted to take photographs as long as they do not disturb, disrupt or interfere with photographer's duties. The photographer has the right to kindly ask the person obstructing to refrain from doing so. Craig Beck reserves the right to use your images for any form of advertising to promote our company.
- **4.0 COPYRIGHT:** Craig Beck retains the copyright of all the photographs produced and it is a criminal offence to make copies from them without permission by any means including video under the terms of the copyright, designs and patents act 1988. If your package includes a high-resolution disc you are automatically granted the right to print and distribute the images.
- **5.0 STYLE & APPROACH:** Craig's style should be considered to be photojournalistic, producing a reportage / documentary style storybook. Essentially the story of your wedding as witnessed by Craig Beck. You should expect between 150 and 250 produced images, supplied on computer disc or USB drive within two to six weeks of your wedding date.
- **6.0 PROOF & 'SIGN OFF':** You will be supplied a PDF proof of how your album will look. Printing will not begin until you provide confirmation in writing that you are happy with the design, selection of photographs and image quality (viewed at 100%). **Alterations from this point on will incur a charge equal to the full price of printing.**
- **7.1 TOTAL FAILURE:** Every care is taken in photographing and processing using professional methods. In the unlikely event of total photographic failure (not being supplied any images) i.e. during exposure or processing, the photographer's liability shall be limited to a full refund of all monies paid. Your statutory rights are not affected.
- **7.2 PARTIAL FAILURE:** The very best branded equipment and storage cards are used at all times. However in very rare cases memory chips can become corrupted or damaged rendering their contents inaccessible. Craig Beck cannot be held responsible for missing images due to unpredictable technical failures such as these.
